## **AISWA Early Childhood Study Tours**

AISWA Early Childhood are thrilled to announce that we will be offering two study tour experiences this year!

- Reggio Emilia Australia Information Exchange (REAIE) Intensive Residential Study Tour (Melbourne): AISWA Early Childhood will sponsor 4 educators to participate in this exciting REAIE study tour in Melbourne (15-17 August 2024). This tour includes accommodation, a variety of seminars and workshops and an opportunity to visit a selection of centres/schools that grow practice from the ideas of the educational project of Reggio Emilia. Each context offers a unique opportunity to explore Australian interpretations and possibilities of the Reggio Emilia principles. AISWA EC sponsorship is valued at \$2350 and includes accommodation. #### **AEDC**

The 2024 AEDC (cycle 6) will play a vital role in assisting Western Australia and Australia in collecting information to support children and families and understand the longer-term impact of COVID-19. All schools should have been activated, and data collection will remain open until 28 June.

**Teacher Relief:** The Australian Government contributes relief funding to schools for relief staff brought in to allow teachers and Aboriginal and Torres Strait Islander Cultural Consultants to participate in the AEDC. Teacher relief includes one-hour of training and 20 minutes per completed instrument per teacher and 20 minutes per completed instrument for each Aboriginal and Torres Strait Islander Cultural Consultant (completed with a teacher) with a minimum of three hours of relief time per teacher.

## **Cultural Responsiveness - Robyn Collard**

AISWA Early Childhood recently hosted a Cultural Responsiveness Professional Learning session with Robyn Collard, AISWA Aboriginal Education Consultant Kristy Ninyette and AISWA Early Childhood team. This targeted project is open to a small number of invited schools, selected based on their Expression of Interest. The project aims to achieve two goals: To broaden participants' cultural education and to develop strategies to embed Aboriginal and Torres Strait Islander perspectives into their classrooms.

On Day One, participants engaged in immersive experiences with Robyn Collard and guest presenters to build their cultural knowledge of the Noongar culture. Robyn Collard welcomed us with a smoking ceremony, shared Noongar Cultural knowledge, and unpacked dates of historical significance for Aboriginal and Torres Strait Islander peoples.



## **Sustainability Workshop at Perth City Farm**

We recently had the pleasure of touring Perth City Farm where we learned about the importance of composting. During the tour, we were given a demonstration on how to compost and its benefits.

We discovered that nearly half of the waste produced by a typical household is organic matter, and composting is an affordable and simple way to redirect organic waste from landfill while also improving soil quality in our gardens.

We were shown various composting systems, such as bins, tumblers, and bays, and we learned that almost all organic matter, including onions, citrus, small amounts of meat, and dairy, can be composted. However, it's important to note that cat or dog poo cannot be included.

We learnt that ensuring the health of the composting system is as simple as maintaining a carbon-tonitrogen ratio of two-thirds nitrogen-rich kitchen scraps and one-third carbon ingredients. Activators such as blood and bone, and animal manures can be added to speed up the process. With this newfound knowledge, we left feeling excited and equipped to set up and maintain composting stations at our schools and homes.

#### Supporting Relational Pedagogy through AISWA's Behaviour Engagement Project

Recently, some of our AISWA-member schools participated in the Behaviour Engagement project with Deb Martin. As part of this project, school staff across WA came together to explore new ways of supporting relational pedagogy in today's classroom contexts along with the exploration of Dr Ross Greene's *Collaborative and Proactive Solutions* framework. Project participants explored practical strategies to supporting restorative practices in school settings.

Building on the key principle of Dr Ross Greene's work *children do well if they can*, participants spent time reflecting on their current approaches and thinking about new ways to supporting children's behaviour by building social and emotional literacy and emotional regulation skills.
