Term 1 is typically the planning phase of NCCD. The key activities as recommended by the Australian Government include:

- Extending or building an understanding of the NCCD in schools.
- Consolidating understanding of the *Disability Discrimination Act 1992* and the Disability Standards for Education 2005.
- Discussing and establishing processes including moderation processes.
- Communicating with students, parents, guardians and carers.

# **INFORMATION**



The Online Safety Amendment (Social Media Minimum Age) Act 2024 introduces a mandatory minimum age of 16 for accounts on certain social media platforms, forming one part of a broader strategy to create safer digital spaces for everyone. The age restriction requirements will take effect by December 2025. The link to the eSafety website with information to support understanding of the social media age restrictions legislation, which will come into effect in December 2025 can be found here.
