

## Special Education Supplementary (SES) Per Capita Grant Funding

- AISWA Inclusive Education provides the avenue for all Independent Schools in Western Australia to access State Government Special Education funding.
- Funding is provided to non-government schools by the WA State
  Government in recognition of the additional costs required to educate a
  student with a disability.

- We ask schools at this time to ensure that your school's Funding Coordinator and Approvers are up to date on the member portal.
- The student database is currently OPEN and available for schools to upload diagnostic reports, documented plans and to complete impact of disability boxes.
- Round 1 applications will open on 20th February and close 26th March 2025.



- The Australian Government Department of Education has advised that the 2025 NCCD Guidelines and updated NCCD Quick Guide, were published on the NCCD Portal on 9 September 2024.
- The <a href="home page">home page</a> of the NCCD Portal has been updated with information about the 2025 NCCD Guidelines and a banner and news item has also been published on SchoolsHub.
- Typically, during Term 1, planning activities are underway for NCCD. This
  is a great time to establish a school team to lead the NCCD and build
